1. **Kepilasgadhi Rural Municipality, Khotang, Nepal** invites open competitive Bidding (Single stage Double Envelop Technical and Price electronic bids in the form of Technical and Price Bids) from eligible Nepalese bidders for the construction of following works under National Competitive Bidding procedures for the bidders with qualification requirements as stated in Section III. 3. Pre-bid meeting shall be held at **Kepilasgadhi Rural Municipality, Khotang** at **2075/07/11** (28th October 2018) at **14:00 Hours**.

4. The Technical Bid and Price bids must be submitted through PPMO's website: www.bolpatra.gov.np/egp; on or before **12:00 Hrs of 2075/07/26 (12th November 2018)**. Bids received after this deadline will be rejected.

5. The bids will be opened in the presence of Bidder's representatives who choose to attend at 14.00 Hrs on **2075/07/26 (12th November 2018)** at the **Kepilasgadhi Rural Municipality, Office of Rural Municipal Executive, Khotang, Province No.1**.

6. Bids must be valid for a period as mentioned in table above after the bid opening and must be accompanied by a bid security issued by an authorized bank (A class Commercial Bank) (Security in the form of cash should be deposited in the Deposit account A/C No.: 2060303007103, **Office Code 12-365-10, Account Name: Kepilasgadhi Ga. Pa, Khotang, Bank name: Rastriya Banijya Bank, Diktel Branch, Khotang**) or scanned copy of the bid security in pdf format in case of e- bid, amounting to a minimum as mentioned table above, which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. The person, firm or company black listed as per Public procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.

9. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulations- 2064 with amendment and other prevailing regulations.

10. If a bidder submits above several successful (lowest evaluated substantially responsive) bids, the evaluation will also include an assessment of the bidder's capacity to meet the aggregated requirements regarding: Experience, Financial Situations, Cash flow capacity, Equipment to be allocated and Personnel to be fielded.
