1. The Government of Nepal has allocated funds towards the cost of Construction of 15 - Bed hospital at Kepilasgadhi Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contract construction of 15 bed hospital at Kepilasgadhi (Contract No. 01/KRM/HB/2078/079). Bidding is open to all eligible as per Section V of bidding document.
2. Kepilasgadhi Rural Municipality invites electronic bids from eligible bidders for the construction of 15 Bed hospital under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

**Only eligible bidders with the following key qualifications should participate in this bidding:**

- **Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 170 Million.**
  - **Minimum Work experience of similar size and nature: at least One RCC Building Contracts within the last ten (10) years, each with a value of at least 155 Million that have been successfully or substantially completed.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
  4. Eligible Bidders may obtain further information and inspect the Bidding Documents by visiting PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
  5. Bidder submitting their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the nonrefundable fee of Nrs 5000 cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at Kepilasgadhi Rural Municipality on 17/08/2021 13:00
7. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on before 12:00 on 27/08/2021. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 27/08/2021 13:00 at the office of Kepilasgadhi Rural Municipality. Bids must be valid for a period of 120 after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a minimum of NRs: 5000000 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
